

**Information Notice on the Processing of Personal Data  
pursuant to Article 13 of Regulation (EU) 679/2016**

**Fondazione di Partecipazione "Network 4 Energy Sustainable Transition" – NEST**, within the framework of the initiative "Call4Innovation" (hereinafter, the "Call"), in its capacity as Data Controller, hereby informs you that, pursuant to Article 13 of Regulation (EU) 679/2016 ("Regulation" or "GDPR") and the applicable national legislation on the protection of personal data, it will process your personal data in compliance with the legal provisions in force, as set out below.

**1. Data Controller and Data Protection Officer**

The processing of personal data is carried out by the Data Controller, **Fondazione di Partecipazione "Network 4 Energy Sustainable Transition" – NEST**, with registered office in Bari, Via Amendola 126/B, 70126, Tax Code and VAT No. 08757160729 (hereinafter, "NEST").

**2. Nature of the Data Processed, Purposes and Legal Basis of the Processing**

For the purposes described below, only common personal data will be processed, such as identification data (name, surname, date and place of birth, tax identification number) and contact details (telephone number and e-mail address) provided by you, as Team Leader, through the completion of the application form, including data relating to additional members of your Team.

With regard to personal data pertaining to third parties that you may provide, you undertake to ensure the accuracy of such data and to be duly entitled to communicate them to NEST.

**The processing of your personal data serves the following purposes:**

- a. **Management of the application and participation in the Call**, including all related activities (e.g., assessment of eligibility requirements, sending of informative and/or organisational communications, preparation of rankings, allocation of awards);
- b. **Marketing activities**, including the promotion of products and services, the sending of personalised commercial offers, and the conduct of surveys or satisfaction questionnaires.

The **legal basis** for the processing of personal data for the purpose under **letter a)** is the necessity to perform a contract to which the data subject is a party (Article 6, paragraph 1, letter b) of the Regulation). Processing for this purpose is mandatory for participation in the Call; failure to provide the requested data will make participation impossible.

The **legal basis** for the processing related to **letter b)** is the **explicit consent** of the data subject, pursuant to Article 6, paragraph 1, letter a) of the Regulation. Therefore, NEST will send promotional and/or commercial content exclusively if the data subject has explicitly provided consent.

The provision of personal data for the purpose under **letter a)** is necessary for the establishment of the contractual relationship and for the provision of the requested service. Consequently, failure or partial provision of such data will prevent NEST from fulfilling the relationship between the parties.

**3. Methods of Processing**

Your personal data will be processed using electronic tools (IT and telematic systems) capable of storing, managing, and transmitting data according to logics and procedures consistent with the purposes described above and in compliance with the principles set forth in Article 5 of the Regulation, including lawfulness, fairness and transparency, data minimisation, accuracy, storage limitation, integrity, and confidentiality.

**4. Data Disclosure**

For the purposes indicated above, your personal data may be disclosed to the following categories of recipients:

- a. individuals or entities appointed and/or instructed to carry out activities related to the organisation and management of the Call, its implementation and execution, as well as third parties responsible for managing the Call's application platform;
- b. individuals or entities collaborating with NEST in performing activities that are instrumental, related or ancillary to the Foundation's role within the scope of the Call.

Your data will be disclosed to such third parties only after they have been appropriately designated as **Data Processors**, or—where applicable—recognised as **independent Data Controllers**, and will be processed by collaborators and/or employees of the Controllers acting within the scope of their respective functions and in accordance with the instructions provided by NEST.

#### **5. Duration of the Processing**

Your personal data will be retained by the **Data Controller** for the entire duration of the Call and for the time **necessary to achieve the purposes** for which they were collected. Where necessary for the establishment, exercise or defence of legal claims, your personal data will be retained for any additional period required by applicable law.

In particular, with regard to the purpose under letter b), NEST will process your personal data for up to 24 months from the time of their collection, and in any case until you withdraw your consent.

#### **6. Rights of the Data Subject**

You are entitled to request from NEST, in accordance with the purposes of processing indicated in this notice, the following:

- a. to obtain confirmation as to whether or not personal data concerning you are being processed, to access the content of such data and to receive information regarding the purposes of the processing (right of access);
- b. to update, amend and/or rectify your personal data (right to rectification);
- c. to request the erasure of your personal data or the restriction of processing of data processed in breach of the law, including data whose retention is not necessary in relation to the purposes for which they were collected or otherwise processed (right to erasure and right to restriction of processing);
- d. to object to the processing at any time (right to object);
- e. to withdraw your consent, where given, without affecting the lawfulness of processing based on consent before its withdrawal;
- f. in the cases provided for by law, to receive a copy of the personal data concerning you in a structured, commonly used and machine-readable format and to request that such data be transmitted to another data controller (right to data portability).

Furthermore, you have the right to lodge a complaint with the competent Supervisory Authority or to seek a judicial remedy if you consider that the processing of your personal data by the Data Controller infringes the Regulation and/or the applicable data protection legislation.
